### **ELIGIBILTY**

# **HOW TO ENTER**

- 6. To enter this Promotion, eligible individuals must make a \$30 minimum spend ("Qualifying Spend") at any specialty Torquay Village retailer displaying a QR code counter card sign, in one transaction, excludes Coles.
- 7. Customers must scan instore the entry QR code which directs to the Torquay Village website (<u>www.</u> <u>https://torquayvillage.com.au/</u>) and enter their details online. Customers must keep a copy of their receipt for proof of spend to enter.
